### Rating Rationale

Acuite has Reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and the short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 9.14 crore bank facilities of Competent Construction Company (CCC). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

### About the Company

Incorporated in 1990, CCC is a proprietorship firm based in Delhi. The firm is engaged in undertaking government contracts for the construction of roads, buildings and bridges among others. It is promoted by Mr. Satya Pal Gupta, the proprietor.

### Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
