Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B**' (read as **ACUITE B**) from '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 12.50 crore bank facilities of Sun Blues on account of information risk. The rating continues to be flagged as "Issuer Not Cooperating" and is based on best available information.

About the Company

Sun Blues was established in 2008 by Mr. S K Sabapathy, Mrs. Ritha Sabapathy and Mrs. P.S Seethamma. The firm is engaged in the quarrying and crushing of boulders to produce blue metal. The firm is also a blue metal agent and manufactures ready mix components, mineral sand, hollow bricks, among others. The manufacturing facility is located near Bangalore.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
