Rating Rationale

Acuité has downgraded the long-term rating to '**ACUITE D**' (read as **ACUITE D**) from '**ACUITE C**' (read as **ACUITE C**) and the short-term rating to '**ACUITE D**' (read as **ACUITE D**) from '**ACUITE A4**' (read as **ACUITE A Four**) on the Rs.52.00 Crore bank facilities of Vigyan Chemicals Private Limited (VCPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information. The downgrade is basis of publicly available information about the company.

About the Company

Vigyan Chemicals Private Limited, established in 2011, is a New Delhi-based company promoted by Mr. Sanjay Jain. The company is engaged in the processing and export of industrial chemicals at Kandla, Gujarat.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
