Rating Rationale

Acuite has downgraded the long-term rating to ‘**ACUITE B**’ (read as **ACUITE B**) from ‘**ACUITE B+**’ (read as **ACUITE B plus**) and reaffirmed the short-term rating of ‘**ACUITE A4**’ (read as **ACUITE A four**) on the Rs. 20.00 crore bank facilities of Sequel Alloys & Wires Private Limited (SAWPL) on account of information risk. The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

About the Company

Sequel Alloys & Wires Private Limited (SAWPL) was established in 2004. The company is promoted by Mr. Sandeep Kumar and Mr. Asit Kumar. The company manufactures specialized alloys, wires and conductors at its facility at Noida Special Economic Zone, Uttar Pradesh. The products portfolio of the company includes coil lead wires, copper clad steel conductors and nickel-plated aluminium and copper wire. The registered office of the company is located in Delhi.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.
