Acuité has reviewed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs.42.80 crore bank facilities of Agarwal TMT Industries Private Limited (ATPL). This rating is now an indicative rating and is based on best available information.

ATPL was incorporated in May 2012 by Mr. Rajan Jain, Mr. Sandip Agarwal, Mr. Sanjay Bindal and Mr. Pradeep Dhandharia. The company commenced commercial operations from February 2015 to manufacture TMT bars at Ahmedabad (Gujarat). The company has an installed capacity of 120,000 tonnes per annum and it currently operates at 90 per cent capacity

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
