SMERA has suspended the long term rating of '**SMERA BB-**'(read as **SMERA double B minus**) assigned to the above mentioned facility of Suman Jewellery (SJ). The suspension follows SMERA's inability to undertake rating surveillance in the absence of requisite information from the company.

SJ, incorporated in 1992, is a Coimbatore-based proprietorship firm engaged in the retail trading of gold and diamond jewellery at its showroom in Coimbatore.

In FY2013-14, the firm achieved PAT of Rs.0.06 crore on operating income of Rs.59.51 crore as compared to PAT of Rs.2.49 crore on operating income of Rs.44.72 crore a year earlier. The net worth of the firm stood at Rs.31.26 crore in FY2013-14 as compared to Rs.30.89 crore a year earlier.
