Rating Rationale

Acuite has reviewed the long term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and the short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs.11.00 crore bank facilities of Trans Health Care India Private Limited (THPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Trans Health Care India Private Limited (THPL) was incorporated in the year 1994 by Mr. Vijayaraghavan and Mr. Gurusamy as founder directors. THPL is a Chennai-based company engaged in trading of medical equipments, consumables and disposables used in the medical industry.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
