Acuite has reviewed long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 10.00 crore bank facilities of Sri Sai Industries (SSI). This rating is now an indicative rating and is based on best available information.

SSI, established in 1998, is a Karnataka based proprietorship concern promoted by Mr. R.V.S Reddy. SSI is engaged in manufacturing of precision sheet metal enclosures which find application in CNC machines and various electrical component enclosures. It also manufactures steel fabricated coffee vending machines and the base frame for transformers. The manufacturing plant is located at Peenya Industrial Estates (Bangalore) on a freehold land measuring 23000 sq.ft. The company caters to Automobile, Railways, Telecommunications and Engineering industry.

Non-cooperation by the issuer/borrower

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
