Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B (read as ACUITE Bf)**' from '**ACUITE B+ (read as ACUITE B plus)**' on the Rs. 10.00 crore bank facilities of Sri Sai Industries (SSI) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Sri Sai Industries (SSI), established in 1998, is a Karnataka based proprietorship concern promoted by Mr. R.V.S Reddy. SSI is engaged in manufacturing of precision sheet metal enclosures which find application in CNC machines and various electrical component enclosures. It also manufactures steel fabricated coffee vending machines and the base frame for transformers. The manufacturing plant is located at Peenya Industrial Estates (Bangalore) on a freehold land measuring 23000 sq.ft. The company caters to Automobile, Railways, Telecommunications and Engineering industry.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
