Rating Rationale

Acuite has reviewed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 6.55 crore bank facilities of Sidana Silk Mills Private Limited (SSMPL). This rating is now an indicative rating and is based on best available information.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

About the Rated Entity:

Incorporated in 1981, Sidana Silk was taken over by Mr.Indrajeetingh Chug in 2002. The company is engaged in the manufacture of grey cloth used in shirtings at Vasai, MIDC - Tarapur Palghar district and has an installed capacity of 3,25,000 MTPM (meters per month). Currently, it operates at 73 percent capacity.

For FY2014-15, Sidana Silk reported profit after tax (PAT) of Rs.0.13 Cr, on operating income of Rs.13.55 Cr, as compared with PAT of Rs.0.24 Cr on operating income of Rs.14.34 Cr in the previous year
