Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE D' (read as ACUITE D)** and short term rating of '**ACUITE D' (read as ACUITE D)** on the Rs. 268.00 crore bank facilities of Prathyusha Resources And Infra Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Prathyusha Resources And Infra Private Limited incorporated in 1989, is a Visakhapatnam-based company engaged in undertaking infrastructure development projects related to building of roads, bridges, canals, pipelines and housing facilities. The overall operations of the company are managed by Mr. P. Raja Rao, Mr. P. V. Bhaskara Rao, Mr. P. V. Prabhakara Rao and Mr. Ravi Sundar.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
