Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE B+' (read as ACUITE B plusa) and the short term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 6.00 crore bank facilities of Vimal Enterprises. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

About the Company

Vimal Enterprises (VE), established in 2001, is a Mumbai based partnership firm promoted by Mr. Dhaval Jain and Mr. Dilip Jain. The firm is engaged in the construction of roads, bridges, irrigation projects and buildings.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
