Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE Bf)rom 'ACUITE B+' (read as ACUITE B plus) and reaffirmed the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs.10.18 Cr. bank facilities of Zebra Pack Private Limited (ZPPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Zebra Pack Private Limited, incorporated in 2004, is a Kolkata based company promoted by Mr. Rohit Anchalia and Mr. Mukesh Chandra Bothra to manufacture multilayer plastic film and printed bags. The company's manufacturing unit is located at Howrah, Kolkata.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
