Acuité has reviewed long-term rating of '**ACUITE B**' (read as **ACUITE B**) and the short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 9.50 crore bank facilities of Lustre Engineering Corporation (LEC). This rating is now an indicative rating and is based on best available information.

LEC was initially established as a proprietorship concern by Mr. B. L. Patharkar in 1951. Subsequently in 2002, LEC was reconstituted as a partnership firm with Mr. Vikas Patharkar and Mrs. Himangi Patharkar as partners. The firm is based at Mumbai and engaged as an electrical contractor undertaking maintenance and repair of power lines and installation of substations on a turnkey basis. The firm mainly caters to government entities in the power sector. LEC has also started manufacture and maintenance of transformers in the nature of overhauling from 2014.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
