Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B**' (read as **ACUITE Bf**) from '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 10.50 crore bank facilities of Radiant Industries (Erstwhile Forge Masters) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Ludhiana based Radiant Industries (Erstwhile Forge Masters) was established as a partnership firm in 2014 by the name 'Forge Masters' which was later changed in FY2018. The firm is managed by partners, Mr. Hardeep Singh, Mrs. Baljeet Kaur and their son, Mr. Prabhdeep Singh. The firm is engaged in manufacturing of bright bars.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
