

## Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) on the Rs. 5.00 crore bank facilities of East India Steel Company (EISC) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

## **About the Company**

Pune based, East India Steel Company (EISC) was incorporated as a proprietorship concern in 2008. The firm was promoted by Mr. Abdul Hameed Hasmullah Choudhary and is engaged in the trading of steel scrap. The godown is located at Chakan.

#### **Unsupported Rating**

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/ borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with an unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
