**The issuer did not co-operate; based on best available information.

Acuité has reviewed the long-term rating of '**ACUITE B+** (read as **ACUITE B plus**) and short term rating of '**ACUITE A4** (read as **ACUITE A four**) on the Rs. 7.00 crore bank facilities of SSB Metal Works (SSMW). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

SSMW was established in 1989 as a proprietorship concern by Mr. Bharat Lunia. The firm was later converted into a partnership firm in 1994 with Mr. Bharat Lunia and Mr. Pravin Lunia as partners. The firm is engaged in manufacturing and export of stationery products such as metal ball point pens, plastic ball point pens, roller pens and geometric boxes. The firm sells its products under the brand name 'RADIUS'. SSMW exports around 90 per cent of its products to Turkey, Russia, Netherland, Thailand, Egypt and Germany.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
