Rating Rationale

Acuité has reaffirmed the short term rating of ‘ACUITE A4’ (read as ACUITE A four) on the Rs.14.00 crore bank facilities of S P International. The rating continues to be flagged as “Issuer Not Cooperating” and is based on the best available information.

About the Company

Established in 1998, S P International is a proprietorship firm, promoted by Mr Promod Mahapatra is a Kolkata based firm engaged in manufacturing and exporting of leather products such as wallets, purses, cardholders and handbags. The firm is a ‘Star Export House’ recognized by the Government of India and exports products mainly to Germany, U.K., Switzerland and others. The manufacturing facility is located at Kolkata.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
