### Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE D' (read as ACUITE D) on the Rs. 5.57 crore bank facilities of Arm & Hammer Forgings Private Limited (AHFPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

#### About the Company

AHFPL, incorporated in 2007, is a Faridabad-based company promoted by Mr. Sanjeev Aggarwal and Mr. Rajeev Aggarwal. AHFPL undertakes the manufacturing of forged components.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with an unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

#### Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuité endeavored to gather information about the entity/industry from the public domain.
