Rating Rationale

Acuite has reaffirmed the long term rating to 'ACUITE D' (read as ACUITE D) on the Rs. 5.57 crore bank facilities of Arm & Hammer Forgings Private Limited (AHFPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

About the Company

Arm & Hammer Forgings Private Limited, incorporated in 2007, is a Faridabad-based company promoted by Mr. Sanjeev Aggarwal and Mr. Rajeev Aggarwal. AHFPL undertakes the manufacturing of forged components.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
