Rating Rationale

Acuite has reaffirmed the long term rating to ‘**ACUITE D**’ (read as **ACUITE D**) on the Rs. 5.57 crore bank facilities of Arm and Hammer Forgings Private Limited (AHFPL). The rating continues to be flagged as “Issuer Not-Cooperating” and is based on best available information.

About the Company

Arm and Hammer Forgings Private Limited, incorporated in 2007, is a Faridabad-based company promoted by Mr. Sanjeev Aggarwal and Mr. Rajeev Aggarwal. AHFPL undertakes the manufacturing of forged components.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
