Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE D**' (read as **ACUITE D**) and the short term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs. 9.00 crore bank facilities of A S Industries. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

A S Industries a Uttarakhand based partnership firm was established in the year 2010 by Mr. P D Sharma, Mr. Sunil Sharma and Mrs. Sunhari Sharma. The firm is engaged in manufacturing of aluminium and zinc casting auto components such as locking systems, door handles, moulds and dyes, handle bar and assemblies, Clutch and brakes and aluminium dye casting and zinc dye casting. The manufacturing facility is located at Haridwar.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
