Rating Rationale

Acuite has downgraded the long-term rating to ‘**ACUITE B+**’ (read as **ACUITE B plus**) from ‘**ACUITE BB-**’ (read as **ACUITE double B minus**) on the Rs. 5.00 crore bank facilities of Vimal Plastics (VP) on account of information risk. The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

About the Company

Vimal Plastics (VP), established in 1981 as a proprietorship concern by Mr Vimal K. Fialoke. VP is engaged in manufacturing of injection molded plastic components. VP has its administrative office and factory unit in Noida, Uttar Pradesh.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
