Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B-**' (read as **ACUITE B minus**) on the Rs. 6.00 crore bank facilities of Janatha Motors (JM). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Janatha Motors (JM), a proprietorship concern, was established in 2010 by Mr. V. Sanjai. The firm is an authorised dealer of TVS two wheelers. The firm deals in motor cycles, mopeds, scooters and also sells spares in Thiruvannamalai district.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
