Acuité has reviewed the long-term rating of '**ACUITE B** (read as ACUITE B)' on the Rs. 9.25 crore bank facilities of Press Tech Engineering India Pvt Ltd (PTPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

PTPL, was established in 2003 by Mr. Tamilrasan and Mrs. Mahalakshmi. The company manufactures Electronic stamping at Coimbatore (Tamil Nadu) and has an installed capacity of 500 MT per month.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
