**Rating Rationale**

Acuite has reaffirmed the long-term rating of ‘**ACUITE C**’ (read as **ACUITE C**) on the Rs. 14.50 crore bank facilities of G N Bullion Private Limited (GNBPL). The rating continues to be flagged as “Issuer Not Co-operating” and is based on the best available information.

**About the Company**

G N Bullion Private Limited (GNBPL), incorporated in 2009, is a Kolkata-based company promoted by Mr. Sanjay Shankar Patil and Mr. Sanjay Verma. GNBPL undertakes manufacturing and trading of gold jewellery. The commercial operations of the company commenced in June 2011. GNBPL outsources the processing activity to job workers. The company deals with domestic jewellery retailers.

**Unsupported Rating**

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.
