Rating Rationale

Acuite has reaffirmed the long-term rating of ‘**ACUITE D**’ (read as **ACUITE D**) on the Rs. 5.95 crore bank facilities of Rolex Reclaim Private Limited. The rating continues to be flagged as “Issuer Not Cooperating” and is based on the best available information.

About the Company

Rolex Reclaim Private Limited (RRPL) was incorporated in 2011 and is a Rajkot-based company engaged in the manufacture of reclaim drubber at Pipalaya (Gujarat). The installed production capacity is 7,200 metric tonnes per annum. The Directors of Rolex Reclaim Private Limited are Mr. Jitendra Kantibhai Bhadeshiya, Mr. Thanmal Hansraj Jain, Mr. Jayeshkumar Kantilal Vadukiya and Mr. Divyesh Karamshibhai Pambhar.
