Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs. 19.28 crore bank facilities of Sri Pavana Keerti Hotels India Private Limited (SPKH). The rating continues to be flagged as "Issuer Not Co-operating" and is based on the best available information.

About the Company

Sri Pavana Keerti Hotels India Private Limited, incorporated in December 2013, is a Hyderabad-based company engaged in running a hotel under the name of 'Kubeera Palace'. The hotel is spread over land area of 1500 sq. yards. Kubeera Palace has 50 airconditioned rooms and banquet hall. The Directors of Sri Pavana Keerti Hotels India Private Limited are Ms Virigineni Adinarayana, Mr Ravi Kumar Kollipara and Ms Kadiyala Suneetha.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
