**Rating Rationale**

Acuite has downgraded the long-term rating to 'ACUITE B' (read as ACUITE Bf) from 'ACUITE B+' (read as ACUITE B plus) on the Rs.12.00 crore bank facilities of Bhairav Embro Designs Private Limited (BEDPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

**About the Company**

Bhairav Embro Designs Private Limited is a Mumbai-based company founded in 1998 and promoted by Mr. Brijesh Singh and Mr. Rangabhadur Singh. The company is engaged in trading of steel coils. The company buys steel coils from manufacturers in bulk and sells the same across India.

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
