## Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B-**' (read as **ACUITE B minus**) from '**ACUITE B**' (read as **ACUITE B**) on the Rs. 14.00 crore bank facilities of Dedhia Builders & Developers India LLP on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

## Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
