About the Company

JHPL, incorporated in 2010, is a Panipat-based company promoted by Mr. Vibhor Jain and Mrs Neeti Jain. The company is engaged in the manufacture and export of carpets and mink blankets at Karnal, Haryana.

For FY2013-14, JHPL reported profit after tax (PAT) of Rs.1.28 crore on operating income of Rs.98.27 crore, as compared with PAT of Rs.1.36 crore on operating income of Rs.54.71 crore in the previous year. The company's net worth stood at Rs.20.53 crore as on March 31, 2014, as compared with Rs.13.42 crore a year earlier.
