## Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B**' (read as **ACUITE B**) from '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 13.00 crore bank facilities of Metals & Metal Electric Private Limited on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

## About the Company

Metals & Metal Electric Private Limited was Incorporated in 1993, Promoted by Mr. Kanthilal Jain And Mr. Gauthamchand Jain. A Chennai based company engaged in trading of wires and cables. Metals & Metal Electric Private Limited is an authorised distributor of wires and cables of Paragon Power Cables Limited (Paragon), KEI Industries Limited (KEI) and Polycab Wires Private Limited (Polycab).

## Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
