Acuité has reviewed the long-term rating to '**ACUITE B+**' (**read as ACUITE B plus**) and short-term rating to '**ACUITE A4**'(**read as ACUITE A four**) on the Rs. 8.39 crore bank facilities of Dinesh Printers. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

DP, established in 1980, is a Bangalore-based proprietorship firm engaged in the printing of medical strips, brochures, annual reports among others.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
