Acuite has reviewed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and short-term rating to '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 8.39 crore bank facilities of Dinesh Printers (DP). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

DP, established in 1980 by Mr. Dinesh, is a Bangalore-based proprietorship firm engaged in the printing of medical strips, brochures, annual reports among others.

#### Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
