Acuité has reviewed long-term rating of '**ACUITE B-**' (**read as ACUITE B minus**) and short-term rating of '**ACUITE A4**' (**read as ACUITE A four**) on the Rs. 20.00 crore bank facilities of SOHAMS FOUNDATION ENGINEERING PRIVATE LIMITED (SFPL). This rating is now an indicative rating and is based on best available information.

Sohams Foundation Engineering Private Limited (SFPL), incorporated in 1995, is a Mumbai-based company promoted by Mr. Vitthal Vaishampayan. The company generally undertakes geotechnical engineering projects which includes activities such as geotechnical investigation, geosynthesis, and ground engineering works. The major customers of the company include The Dharma Port Company Limited, SMC Infrastructure Private Limited and ITD Cementation India Limited.

Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
