## Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B-**' (read as **ACUITE B minus**) and the short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 20.00 crore bank facilities of Sohams Foundation Engineering Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

## About the Company

Sohams Foundation Engineering Private Limited (SFPL), incorporated in 1995, is a Mumbai-based company promoted by Mr. Vitthal Vaishampayan. The company generally undertakes geotechnical engineering projects which include activities such as geotechnical investigation, geosynthesis, and ground engineering works. The major customers of the company include The Dharma Port Company Limited, SMC Infrastructure Private Limited and ITD Cementation India Limited.

## Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

## Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower).
