Rating Rationale

Acuite has reaffirmed the long-term rating of ‘**ACUITE B-**’ (read as **ACUITE B minusa**) and the short term rating of ‘**ACUITE A4**’ (read as **ACUITE A four**) on the Rs. 20.00 crore bank facilities of Sohams Foundation Engineering Private Limited. The rating continues to be flagged as “Issuer Not-Cooperating” and is based on best available information.

About the Company

Sohams Foundation Engineering Private Limited (SFPL), incorporated in 1995, is a Mumbai based company promoted by Mr. Vitthal Vaishampayan. The company generally undertakes geotechnical engineering projects which include activities such as geotechnical investigation, geosynthesis, and ground engineering works. The major customers of the company include The Dharma Port Company Limited, SMC Infrastructure Private Limited and ITD Cementation India Limited.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.
