### Rating Rationale

Acuité has reviewed the long-term rating of '**ACUITE BB**' (read as **ACUITE double B**) and short-term rating of '**ACUITE A4+**' (read as **ACUITE A four plus**) to the Rs. 9.00 crore bank facilities of Data Tech Computers Private Limited (DTCPL). This rating is now an indicative rating and is based on best available information.

### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

### About the Rated Entity:

DCPL was incorporated in 1996 by Mr. Rakesh Patel, the company is engaged in the trading of computer hardware products (i.e. laptops, desktops and other computer peripherals) and provides information technology enabled services (ITES) (i.e. network infrastructure design & maintenance, data security auditing, website design & development). DCPL has its head quartered at Ahmedabad in Gujarat with branch office in Australia.

For FY2016-17, DTCPL reported PAT of Rs.1.43 crore on operating income of Rs.42.98 crore as against PAT of Rs.1.03 crore on operating income of Rs.40.68 crore for FY2015-16. The net worth stood at Rs.6.36 crore as on March 31, 2017 against Rs.4.32 crore a year earlier.
