TCCPL, incorporated in 2000, is a New Delhi-based company engaged in the manufacturing of electrical wires and cables including teflon, rubber, telephone among others at Ghaziabad. The total production capacity is 75 lakh meters per annum.

For FY2013-14, TCCPL reported profit after tax (PAT) of Rs.0.26 crore on operating income of Rs.36.21 crore, as compared with profit after tax (PAT) of Rs.0.28 crore on operating income of Rs.35.91 crore in FY2012-13. The net worth stood at Rs.11.86 crore as on March 31, 2014 against Rs.12.84 crore a year earlier.
