Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE D**' (read as **ACUITE D**) and the short term rating of '**ACUITE D**' (read as **ACUITE D**) the Rs. 61.44 crore bank facilities of Durairaj Mills Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Coimbatore based Durairaj Mills Limited, was incorporated in 1983. It is engaged in the business of manufacturing of cotton hosiery and warp yarn. Mr. Duraiswamynaidu Kanagaraj, Mr. Pethanaickenpalayam Duraiswamynaidu Damodaran, Mr. Duraiswamynaidu Jayachandran, Mr. Duraiswamynaidu Ramaswamy, Mr. Palaniswamy Karuppasamy are directors of the company.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower).
