Rating Rationale

Acuite has reaffirmed the long term rating to '**ACUITE D**' (read as **ACUITE D**) on the Rs. 5.02 crore bank facilities of Dharranee and Co(DC). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

About the Company

Dharranee and Co was incorporated in 2011 and promoted by Mr. M. Ravindran to undertake trading of roofing sheets in Coimbatore.

About the Group

Dharranee Group is engaged in manufacturing and trading of roofing sheets. The group started its operations in 1992 by establishing a proprietorship concern named Dharranee and Company which was promoted by Mr. M. Ravindran to undertake trading of roofing sheets. Later in the year 2013 Dharranee Roofing Plant Private Limited was established to manufacture roofing sheets.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
