**Rating Rationale**

Acuite has downgraded the long-term rating to ‘**ACUITE B-**’ (read as **ACUITE B minus**) from ‘**ACUITE B**’ (read as **ACUITE B**) on the Rs. 6.37 crore bank facilities of Dignus Infra Private Limited (DIPL) on account of information risk. The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

**About the Company**

Dignus Infra Private Limited (DIPL), incorporated in 2013, is a Chandigarh-based company promoted by Mr. Niraj Kumar Singh, Mr. SK Shahi, Mr. RS Patel and Mr. Satpal Dagar. The company is engaged in manufacturing of polyurethane industry panels, roofing panels, tile Profiles and crimp profiles.

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.
