Rating Rationale

Acuite has reaffirmed the long term rating of ‘**ACUITE D**’ (read as **ACUITE Do**) on the Rs. 5.50 crore bank facilities of Macro Apparels International Private Limited (MAIPL). The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

About the Company

Macro Apparels International Private Limited (MAIPL), incorporated in 2013, is a Pune-based company engaged in the production of readymade garments. The company is promoted by Mr. Bharat Akulwar and the manufacturing unit is located in Ahmednagar.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
