Rating Rationale

Acuité has reviewed the long-term rating of '**ACUITE D' (read as ACUITE D)** and short term rating of '**ACUITE D' (read as ACUITE D)**' on the Rs.8.71 crore bank facilities of Water Jet Germany Private Limited (WJGPL). This rating is now an indicative rating and is based on best available information.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

WJGPL incorporated in 2005 by Mr. Sivaraman Nair Krishnaprasad and Mr. S. Sriram is engaged in the manufacturing of CNC cutting machines and systems at Chennai.

For FY2014-15, WJGPL reported net loss of Rs.3.36 crore on operating income of Rs.3.43 crore compared with net loss of Rs.1.12 crore on operating income of Rs.5.65 crore in FY2013-14.
