Acuite has reviewed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) and the short term rating of '**ACUITE A4**' (read as '**ACUITE A four**') on the Rs. 9.95 crore bank facilities of M K V K Timber Industries (MKTII). This rating is now an indicative rating and is based on the best available information.

MKTII a partnership firm, established in 1988 by Mr. M.K.V.K. Paulrajan, Mrs. P. Vasanthi, Mr. P. Nithyanandarajan and Mrs. T. Jayanthi. The firm is a part of MKVK Group and is engaged in the trading of timber. The firm is located at Pavorchatram, Tamil Nadu.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
