## **Rating Rationale**

Acuité has reaffirmed long-term rating of 'ACUITE B+' (read as ACUITE B plus) and short term rating of 'ACUITE A4' (read as 'ACUITE A four') on the Rs. 8.25 crore bank facilities of Filteration Engineers India Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

#### About the Company

FEIPL, incorporated in 1994, is a Mumbai-based company engaged in the manufacture of industrial filters and strainers that find application in refineries, petrochemical plants and other engineering industries. The company is promoted by Mr. Sunil Agarwal, who possess around three decades of experience in the filteration industry. For FY2014-15, FEIPL reported profit after tax (PAT) of Rs.0.40 crore on operating income of Rs.16.69 crore as compared with PAT of Rs.0.43 crore on operating income of Rs.11.74 crore for FY2013-14. Further, FEIPL reported PAT of Rs.0.62 crore on operating income of Rs.13.71 crore (Provisional) for FY2015-16

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
