Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE Bf)rom 'ACUITE B+' (read as ACUITE B plus) and reaffirmed the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 8.25 crore bank facilities of Filteration Engineers India Private Limited on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Mumbai-based, Filteration Engineers India Private Limited was incorporated in 1994. It is a company engaged in the manufacturing of industrial filters and strainers that find application in refineries, petrochemical plants and other engineering industries. Mrs. Sunita Agarwal, Mr. Sunil Agarwal are directors of the entity.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
