Acuité has reviewed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs.6.95 crore bank facilities of Prakash textiles. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Prakash Textiles, established in 1986 is a Tamil Nadu-based partnership firm led by Mr. Prakash Subbaiyan and Mrs. P. Manonmani. The firm is engaged in the manufacturing and trading of grey fabric at Coimbatore and has installed capacity of 90 lakh meters per annum.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
