Samtech, established in 1999, is a New Delhi-based proprietorship firm engaged in the trading of textile machinery, used for sewing, cutting, weaving and knitting applications.

For FY2013-14, Samtech reported profit after tax (PAT) of Rs.0.36 crore on operating income of Rs.26.55 crore, as compared with PAT of Rs.0.27 crore on operating income of Rs.25.28 crore in the previous year. The firm's net worth stood at Rs.1.54 crore as on March 31, 2014, as compared with Rs.1.38 crore a year earlier.
