Acuité has reviewed the long-term rating of '**ACUITE BB**' (read as **ACUITE double B**) and short-term rating of '**SMERA A4+**' on the Rs. 13.50 crore bank facilities of Wig Brothers India Private Limited (WBPL). This rating is now an indicative rating and is based on best available information.

WBPL, incorporated in 1996, is a Haryana based company that undertakes construction activities in the residential, commercial and industrial segments.

Non-cooperation by the issuer/borrower:
